Webber holds a Master of Music in Opera Performance from the University of Maryland at College Park and completed his undergraduate work with University of North Carolina School of Arts. At UNCSA Webber was awarded a William R. Kenan Jr. Excellence Award from the William R. Kenan, Jr. Charitable Trust.

Webber balances his love of music and teaching with performing. He has been privileged to sing for political figures including Justice Breyer, Jeb Bush, and Justice Ginsberg. This past summer Webber made his main stage debut at The Princeton Festival as Rector Adams, Benjamin Britten's Peter Grimes.

With over 12 years of studying voice Weber has performed with Opera Theater of the Rockies, A.J. Fletcher Opera Institute, Piedmont Opera in North Carolina, Chautauqua Opera, and the American Institute of Musical Studies program in Graz, Austria. Mr. Webber also performed in many productions with the Maryland Opera Studio including *Die Fledermaus*, *Love/Hate*, *Così fan tutte*, and premiered the role of Justice Scalia in a new works reading of the opera *Scalia/Ginsberg*.

ABOUT THE CHOREOGRAPHER: Carol Johnson returns for her third Imagine Production having joined the staff this past summer for *Aladdin*. Carol holds a BS degree in Dance from Radford University and also studied with the Eglevsky School of Ballet and Point Park College in Pittsburgh, PA. Carol has choreographed numerous musicals and industrials for theatre, companies, schools, and businesses in North Carolina and Virginia. She has served on the faculty of University of N.C School of the Arts Winter Dance Festival since 1997. Carol also serves on the dance faculty with Taylor Dance.
